All participants must read these before signing the registration form

1. These terms and conditions apply to you if The Garwood Foundation accepts your registration for the Virgin London Marathon
2. The Garwood Foundation reserves the right not to accept your application for registration, in which case we will return your registration fee.
3. You will only be entitled to take part in the event in support The Garwood Foundation if you:
 - 3.1 complete and sign the appropriate registration form and return it to The Garwood Foundation
 - 3.2 will be over the minimum age of 18 years on the day of the event.
4. The Garwood Foundation requests the balance of the fundraising target to be paid to The Garwood Foundation within four weeks after the event.
5. If, for any reason, you choose not to take up your place or the event is cancelled, all sponsorship forms and money collected must be delivered and paid to The Garwood Foundation.
6. In carrying out all fundraising you agree:
 - 7.1 to obtain and pay to us all sums pledged through your efforts
 - 7.2 to tell all sponsors that:
 - a) the money raised benefits The Garwood Foundation (a registered charity)
 - b) the cost for your participation with a guaranteed place in the event will be paid by the Foundation from the donations.
 - c) donations will not be refundable, even if the event does not take place or you do not participate in or complete the event.
 - 7.3 to establish a personal account at Virgin Money Giving linked to The Garwood Foundation
 - 7.4 to ask sponsors to make payments to you either by electronic payments to Virgin Money Giving or by sending money to you; payments are not to be made directly to The Garwood Foundation.
 - 7.5 to keep a record of all sponsorship money raised and all money sent to The Garwood Foundation.
 - 7.6 to inform us of any public event that you are putting on
 - 7.7 to keep the names of your sponsors (we may ask for these details)
 - 7.8 to make it clear you are not an employee or agent of The Garwood Foundation
 - 7.9 to wear a T-shirt or vest supplied by and representing The Garwood Foundation
 - 7.9 not to reproduce The Garwood Foundation logo but to contact us for official materials
 - 7.10 not to collect in a private place (e.g. local shop, pub etc) without the prior permission of the owner
 - 7.11 not to collect in a public place without first obtaining a collector's license from the relevant authority
 - 7.12 not to raise funds by carrying out house to house collections
 - 7.13 not to raise funds by conducting a lottery or a raffle
 - 7.14 not to do anything to bring the name of The Garwood Foundation into disrepute.
7. All money raised which is not donated via Virgin Money Giving must be paid to The Garwood Foundation registered charity number 272905. You must send all sponsorship money directly to The Garwood Foundation, 1^A Melville Avenue, South Croydon CR2 7HZ.
8. The Garwood Foundation may terminate the agreement between you and us by sending you written notice. You shall then immediately stop raising funds for The Garwood Foundation and shall pay to the Foundation any sums raised before termination. You must still keep sponsors' details and provide them to us on request.
9. In the event of you sustaining any injury or suffering any illness which might prejudice your capacity to take part in the event you must let the Foundation know at the earliest opportunity so that an alternative runner can be arranged and any reduction in sponsorship income thereby avoided. If you have to notify the Garwood Foundation of any such injury or condition which does not prejudice your participation in the following year's marathon you will be offered a guaranteed entry for that year.
10. This agreement constitutes the entire agreement and understanding between The Garwood Foundation and you relating to the event and supersedes all other representations, agreements, or arrangements whether written or oral, express or implied relating to the event. It may only be amended in writing and signed by you and The Garwood Foundation.
11. You take part in the event at your own risk. The Garwood Foundation is acting as your agent for making arrangements with the event organiser. The event organiser is responsible for ensuring the safety and proper running of the event. Therefore, except in the case of personal injury or death arising from our own negligence the Foundation does not accept any liability for any loss or damage, however arising, or from cancellation of the event for reasons outside its control.
